ADDENDUM NO. 1

Prospective proposers and all concerned are hereby notified of the following change(s) in the BID DOCUMENTS ARFF VEHICLE. The(se) change(s) shall be incorporated in and shall become an integral part of the proposal documents. All proposers must acknowledge this addendum on the Acknowledgement of Addenda form to be submitted as part of their proposal.

- 1. **Page 1, 3**rd **Paragraph**: Delete the sentence: "Sealed bids will be received at the above address until 2:00pm on Friday April 12, 2024"; and insert the following language, "Sealed bids will be received at the above address until 2:00 pm on Friday April 19, 2024."
- 2. **Page 2, 2**nd **Paragraph**: Delete the sentence: "Sealed bids will be received at the above address until 2:00pm on Friday April 12, 2024"; and insert the following language, "Sealed bids will be received at the above address until 2:00 pm on Friday April 19, 2024."
- 3. Page 12, Bid Form: Delete the sentence: "The vehicle shall be delivered to Tweed-New Haven Regional Airport, 155 Burr Street, New Haven CT 06512 within 360 days of the Authority's "Notice to Proceed"; and insert the following language, "The vehicle shall be delivered to Tweed-New Haven Regional Airport, 155 Burr Street, New Haven CT 06512 within 550 days of the Authority's "Notice to Proceed"
- 4. **Page 12, Bid Form:** Delete the sentence; "The delivery date of this equipment shall not exceed 360 days from issuance by the Authority of a "Notice to Proceed," and insert the following language, "The delivery date of this equipment shall not exceed 550 days from issuance by the Authority of a "Notice to Proceed."
- 5. Page 46, Time for Completion & Damages for Delay: Delete the sentence: "All work specified in these specifications and Contract Documents is to be completed within three hundred and sixty (360) days after receipt of the Notice to Proceed from the Authority;" and insert the following language, "All work specified in these specifications and Contract Documents is to be completed within five hundred and fifty (550) days after receipt of the Notice to Proceed from the Authority."

- 1. **Pages 19-20, Bid Bond**: Replace pages 19 and 20 of the Bid Documents with the attached for the Bid Bond Form.
- 2. **Page 33, 4. State and Local Sales Tax Exemption**: The Airport Authority is exempt from State and Local taxes for a motor vehicle purchase.
- 3. Page 60, Insurance: Delete the following sentence, "All Commercial General Liability Policies must be primary and non-contributory with a waiver of subrogation included on behalf of Tweed-New Haven Airport Authority, Avports LLC, the city of New Haven, and the Town of East Haven," and insert the following language, "All Commercial General Liability Policies must be primary and non-contributory with a waiver of subrogation in favor of Tweed-New Haven Airport Authority, Avports LLC, Avports HVN LLC, and The New HVN LLC."
- 4. Page 60, Insurance: Delete the following statement, "The contractor shall provide certificates of insurance showing coverage by an insurance carrier authorized by the State of Connecticut to write insurance in the State. Said certificate shall contain the following endorsement: "The Tweed-New Haven Airport Authority, AFCO AvPORTS Management LLC, the City of New Haven, and the Town of East Haven shall be named as additional insured parties to the extent their interests may appear. The additional insured provision does not apply to Workers' Compensation coverage," and insert the following language, "The contractor shall provide certificates of insurance showing coverage by an insurance carrier authorized by the State of Connecticut to write insurance in the State. Said certificate shall contain the following provision/endorsement: "The Tweed-New Haven Airport Authority, Avports LLC, Avports HVN LLC, and The New HVN LLC are additional insureds as their interests may appear. The additional insured provision does not apply to Workers' Compensation coverage."
- 5. Page 89, 3.6.5 Foam Testing System: Delete the sentence, "The vehicle must have piping, internal modification, cart, trailer, or other equipment need to support NFPA 412 input-based testing," and insert the following language, "The vehicle shall be equipped with either an on-board foam proportioning in-put based testing system or plumbing for an external foam proportioning testing system."

- 6. Page 91, 3.6.8 Pre-connected handline(s): Delete the sentence "Two 200 foot, 1 ¾ inch pre-connected woven jacket handline(s), with 1 ½ -inch control valve and a piston grip nozzle, will be located on (or accessible from) left side of the vehicle," and replace with the following language, "One 200 foot, 1 ¾ -inch pre-connected woven jacket handline(s), with 1 ½ -inch control valve and a piston grip nozzle, will be located on (or accessible from) left side of the vehicle."
- 7. Page 91, 3.6.7.1: Delete the sentence, "In addition, the vehicle will be equipped with the following handline: 100 feet of twinned 1-inch dry chemical/foam-water hose on a reel," and insert the following sentence, "In addition, the vehicle will be equipped with the following handline: 150 feet of 1-inch dry chemical hose on a reel."
- 8. **Page 101 & 102**, **Packaging 6.3**: Type of foam required is that which meets DOD MIL-PRF-32725 specifications for Fluorine Free Foam.
