Bids for **West Ramp Rehabilitation** at Tweed-New Haven Airport will ONLY be received and accepted via online electronic bid service through <https://www.questcdn.com> until 2:00 PM, September 19, 2024 local time and at such time will be opened online. Anyone interested in witnessing the public bid opening over the phone or internet is to contact Hoyle Tanner for a link to the open conference call. Please contact Donna Akerley, dakerley@hoyletanner.com, (603)-460-4934 for meeting information at least five (5) days prior to the scheduled bid opening. The 5-day lead time is required in case the bid opening time changes.

The project constructs concrete pads for standing and parked aircraft to prevent rutting and premature surface deterioration at locations within the West Ramp limits. In addition, there will be pavement rehabilitation of mill and inlay of existing HMA surfaces for Gates 1 – 5. There will be drainage improvements to mitigate standing water and ponding conditions within the West Ramp and Deicing Area and lighting of the Ramp Area.

Bids shall be on a unit price basis, as indicated in the Bid Form.

Complete digital Bidding Documents may be obtained or viewed on or after August 27, 2024 at the website of Hoyle Tanner, www.hoyletanner.com by clicking the “Bid Portal” tab and selecting the above referenced project. You must set up your membership with QuestCDN, www.questcdn.com and pay a download fee of \$50.00 before downloading the Bidding Documents. To bid on this project and be considered a plan holder, the Bidder MUST download the digital project bidding documents from QuestCDN and pay the download delivery fee. Neither owner nor engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than QuestCDN.

Bidder shall submit a bid via online electronic bid service through QuestCDN, www.questcdn.com (see Instructions to Bidders). A pre-bid conference will be held at 11:00 AM, Thursday, September 5, 2024 at Tweed-New Haven Airport, 155 Burr Street, 2nd Floor Administration Building, New Haven, CT 06512. This will be the only time for prospective Bidders or subcontractors to view the site. Bidders must advise Nils Gonzalez, ngonzalez@hoyletanner.com, 603-460-5167 if they are to attend. All interested bidders are requested to attend in order to prepare acceptable bid submissions.

Prospective bidders are asked to provide information on whether their company is listed as a Disadvantaged Business Enterprises (DBE) in the state where the work will be performed in order to comply with FAA regulations. Prospective bidders will be asked to provide this information at time of plan purchase.

The Owner reserves the right to waive any informality in the bidding or to reject any or all bids.

Each bidder must deposit with their bid, security in the amount of 5% of the bid in the form and subject to the conditions provided in the General Provisions.

Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the Contract. The Contractor on this work will be required to comply with the equal employment opportunity requirements of the Federal Aviation Administration and the Tweed-New Haven Airport DBE Program.

No bidder may withdraw any bid prior to September 30, 2024.
